4. Contract Award, Term,

When the Contract is awarded, the Contractor will contact Rusk County Representative to arrange the work schedule and hours of the day that the workmen may be on the building. The job is to be bid under the assumption that all work will be performed on a straight time basis.

Following the base term and any allowable extensions, The County may extend any resulting Contract for the purpose of completing a new procurement, and/or to transition to a new vendor if necessary to avoid interruption in Entity services.

Contract Term

As a result of this RFP, The County reserves the right to award one Firm Fixed Price Contract. Interested parties may submit request for proposal by 11/14/2022. Questions are due for this RFP by 11/7/2022.

Offeror(s) must be not debarred at the time of submittal and complete the attached 'Non-Debarment Self Certification' Form. Prior to award, the offeror must provide proof of registration, active/good standing and non-debarment status in the System for Award Management. SAM.gov will be checked prior to award of the contract. If an offeror is not registered with SAM.gov, or the offeror is debarred, then the offeror's proposal will not be evaluated.

5. No Guarantee of Volume, Usage or Compensation

The County makes no guarantee of volume, usage, or total compensation to be paid to any Respondent under any awarded Contract, if any, resulting from this Solicitation. Any awarded Contract is subject to appropriations and the continuing availability of funds.

6. Governmental Entities

The selected respondent shall be bound to specific terms and conditions found in Part 200 of the Uniform Administrative Requirements, Cost Principles, and Audit Requirement for Federal Awards and Title 10, General Government; Subtitle F, State and Local Contracts and Funds Management; Chapter 2252.

7. Other Applicable Conditions

Respondents must meet the minimum qualifications listed below. 20. Evaluation Criteria

Solicitation responses shall be evaluated in accordance with Part 200 of the Uniform Administrative Requirements, Cost Principles, and Audit Requirement and Chapter 2254 of the Texas Government Code. The Entity will make the selection on the basis of demonstrated competence and qualifications; and to a respondent that negotiates a fair and reasonable price.

21. Specific Criteria

Solicitation responses shall be consistently evaluated and scored based on responsiveness and price.

22. Other Information

The Entity may contact references provided in response to this Solicitation, contact respondent's clients, or solicit information from any available source.

23. Initial Compliance Screening

The Entity will perform an initial screening of all solicitation responses received. Unsigned solicitation responses, and solicitation responses that do not meet the minimum qualifications above and/or do not include all required forms and information may be subject to rejection without further evaluation.

24. Additional Evaluation Criteria

All solicitations will be evaluated based on Responsiveness and Price. Responsiveness means adhering to the Terms and Conditions and specifications of the supplies requested. If an offeror(s) who has the lowest price is deemed to be non-responsive, Entity will disqualify the offer and evaluate the response of the next lowest priced responsive offeror.

25. Competitive Range and Best and Final Offer

The Entity may determine that certain solicitation responses are within the competitive range and may use this range to award multiple Contracts. If the Entity elects to limit award consideration to a competitive range, the competitive range will consist of the solicitation responses that receive the highest or most satisfactory ratings, based on the published evaluation criteria and procedures governing this procurement. The Entity, in the interest of administrative efficiency, may place reasonable limits on the number of solicitation responses that will be included in the competitive range.

Part A – 20 YEAR ROOF RESTORATION MONOLITHIC SYSTEM

Attached, Scopes of Work, Component sections, forms a component part of this section. Infrared Moisture scan must be completed and certify that less than 25% of the roofing insulation is wet and that the roof can be restored per manufactures guidelines.

- 1. Remove all wet/damage roofing as identified per the county's designated infrared scan to the roof deck. All debris must be hauled away.
- 2. Replace wet insulation areas and all flashings with Poly ISO and modified bitumen base and cap sheet that meet ASTM performance criteria D6163, and D5147. Adhesive for base and cap sheets must have a VOC of 0 g/L, a 100% non-volatile rating per ASTM D 4586 and have a flash point of 400°F or higher per ASTM D 93.
- 3. Entire Membrane must be washed at 2,000 PSI minimum with non-toxic cleaning solution (must be compatible with manufacturers materials and systems).
- 4. Apply base coat of monolithic roof restoration system with a VOC of 0 g/L, a tensile load strain of 135 lbf.in or better per ASTM D 5147, a dynamic impact resistance of 37 joules or better per ASTM D 5635, a tensile strength of 2,500 psi or better per ASTM D 412 and an elongation of 400% or better.
- 5. If manufacture requires reinforcement in system to meet standards than follow application guide provided by manufacture.
- 6. Install top coating if necessary per manufacture installation instructions. Finished product must be certified by manufacture minimum of 20 years. System must be 80 mils or thicker.
- 7. All gas lines to be painted with Low VOC Hazard yellow paint with a VOC of 50 g/L or better.
- 8. New rubber pipe blocks must be installed per manufactures systems recommendations.

Protect all surfaces while performing work and where needed provide temporary surface to operate equipment necessary to perform above mentioned work.

Part A – 30 YEAR ROOF REPLACEMENT

- 1. Remove entire roof system down to original deck. All debris must be hauled away.
- 2. Install 120 mil vapor barrier per manufacture installation instructions.
- 3. Apply (2) layers of 2.2 Poly ISO insulation per building code R25 minimum required value and per manufactures windup lift calculations.
- 4. Install new crickets to deflect water around North walls and into gutters on the NE and NW sides of the building. Owners Rep/Manufacture must be on site to inspect and approve drainage per crickets before roof system can be completed. Cricket design must be completed by manufacturer or Owners Rep.
- 5. Install ½" coverboard per manufactures windup lift calculations. Coverboard to be Secure Rock or Dens deck. No Wood fiberboard will be accepted.
- 6. Install modified bitumen base sheet with a passing rating for low temperature flex per ASTM D 6162 and ASTM D 5147, an elongation of XD 8% or better, a Tear strength of 500 lbf or better and a tensile strength XD of 210 lbf/in or better. Nominal thickness to be 75 mils or thicker.

- 7. Base sheet to be fully adhered with modified bitumen adhesive. Adhesive to have a VOC of 5 g/L or better, a 98% non-volatile rating or better per ASTM D 4586, a flashpoint of 400°F or higher per ASTM D 93 and a density at 77° of 11.4 lbs/gal or better.
- 8. Install modified bitumen cap sheet with a passing rating for low temperature flex per ASTM D 6163 and ASTM D 5147, an elongation of XD 5% or better, a Tear strength of 275 lbf or better and a tensile strength XD of 210 lbf/in or better. Nominal thickness to be 130 mils or thicker. Cap sheet must have mineral or surfacing. Roofing cannot be black coat finished.
- 9. Install new modified bitumen cap sheet in with adhesive per base sheet adhesive spec.
- 10. Install new edge metal and drip edge in accordance with manufacturers installation instructions.
- 11. New rubber pipe blocks must be installed per manufactures systems recommendations
- 12. All gas lines to be painted with Low VOC Hazard yellow paint with a VOC of 50 g/L or better.
