CONCERNING MISDEAMEANORS

It is **ORDERED** that all defendants, with pending misdemeanor cases filed in the Rusk County Court at Law, who are NOT represented by an attorney for each misdemeanor case, must **APPEAR** (in person) at the JP 5 Courtroom located at 210 W Charlevoix St #304, Henderson, TX 75652 for Docket Call on October 7, 2022 at 8:30 a.m. and at the places and times set forth below.

Pre-trial Motions Deadline: October 6, 2022 at 4:00 p.m.

Docket Call: JP 5 Courtroom on October 7, 2022 at 8:30 a.m.

Pre-trial (short-list) Docket Call: CCL on October 25, 2022 at 9:00 a.m.

Jury Trial Selection: CCL Courtroom October 28, 2022 at 8:30 a.m.

Bench Trial Docket Call: CCL November 1, 2022 at 9:00 a.m. (if jury waived)

Failure to appear to at the time and places cited, without a continuance, as ORDERED will result in the forfeiture of bond and issuance of an Arrest (CAPIAS) Warrant for the arrest of the Defendant, and upon arrest, setting of a cash bond to be released from jail.

Attorneys for Defendants may appear in person or e-mail their announcements to cdean@ruskcountytexas.gov and copy the District Attorney's Office. Cases under 6 months old with a "Not Ready" announcement will be passed to the next docket. A "Not Ready" announcement on a case over six months old will require a hearing to continue unless there is an agreed pass signed in writing by the county attorney. All other cases will be set for jury selection with trial dates to be set at the jury selection or bench docket if jury is waived. For updates, continue to check our website on the Rusk County Website.

It is further ORDERED that the District/County Clerks issue 200 subpoenas for jurors to appear for jury selection on the Jury Trial Selection date.
