- Pretrial motions are pending, or
- Defendant's announcement is Not Ready

IF DEFENDANT'S ANNOUNCEMENT IS READY IT MAY BE MADE IN WRITING TO THE COURT AT LEAST THREE (3) WORKING DAYS BEFORE THE ABOVE DOCKET CALL DATE:

- The Ready announcement must set out that the Defendant has been notified of trial date
- IF the Defendant announces Ready, but requires a pretrial hearing, Defendant and attorney must be present for the pretrial on the day of docket call.

No case will be passed for a plea pursuant to a plea agreement with the State unless a signed Waiver of Jury is delivered by the Defendant's attorney to the District Attorney's Office by 4:00 p.m. on Monday, before Jury Selection on August 17, 2026.
