IF DEFENDANT'S ANNOUNCEMENT IS READY IT MAY BE MADE IN WRITING TO THE COURT AT LEAST THREE (3) WORKING DAYS BEFORE THE ABOVE DOCKET CALL DATE:

- The Ready announcement must set out that the Defendant has been notified of trial date
- IF the Defendant announces Ready, but requires a pretrial hearing, Defendant and attorney must be present for the pretrial on the day of docket call.
