## TRAFFIC OFFENSES IN CONSTRUCTION/MAINTENANCE ZONE FINES ARE DOUBLED WHEN WORKERS ARE PRESENT

### SPEED FINE

1-5 MPH over posted limit.....\$150.00 (JP5 \$152.00)

6-10 MPH over posted limit.....\$185.00 (JP5 \$187.00)

(for EACH mph over this, add \$5.00 to the original \$185.00 (JP5 \$187.00))

90 MPH & above.....\$300.00 (JP5 \$302.00)

Speeds 25 mph or over posted limit are not eligible to be covered with Driving Safety Course.
